#### Decisions

- Argued in Arc in Hawaii v. DB Ins. Co., CV 20-00112-ACK-WRP, 2021 WL 2481672 (D. Haw. June 17, 2021). The district court awarded \$2.3 million to the insured based on coverages for forgery and employee dishonesty
- Argued in *Hungate v. Law Office of David B. Rosen*, 139 Hawai'i 394, 391 P.3d 1 (2017). The Hawai'i Supreme Court upheld dismissal of claims by a mortgagor against an attorney who conducted the non-judicial foreclosure
- Argued in *Lima v. Deutsche Bank Nat'l Tr. Co.*, 690 F. App'x 911 (9th Cir. 2017). The Ninth Circuit upheld dismissal of claims by a mortgagor against an attorney who conducted the non-judicial foreclosure
- Contributing brief author in *Hotelco HI HO LLC v. Thyssenkrupp Elevator Corp.*, No. CV 16-00625 KJM, 2017 WL 10647375, at \*1 (D. Haw. Dec. 31, 2017). The court granted summary judgment on elevator company's claims and granting summary judgment on the vast majority of the customer's claims
- Contributing brief author in *Kaheawa Wind Power*, *LLC v. County of Maui*, 146 Hawai'i 76, 456
  P.3d 149 (2020). The Hawai'i Supreme Court held that the county could not tax wind towers and turbines as "real property" under the Hawai'i Constitution
- Contributing brief author in *Trustees of Estate of Bishop v. Au*, 141 Hawai'i 248, 407 P.3d 1284, 2017 WL 6614566 (Ct. App. 2017) (unpublished summary disposition order). The appellate court upheld summary judgment in favor of the landlord, terminating the lease, awarding damages, and dismissing the tenant's counterclaims
- Contributing brief author in *Au v. Trustees of Estate of Bishop*, No. CV 20-00218 JAO-WRP, 2020 WL 5550388, at \*1 (D. Haw. Sept. 16, 2020). The district court dismissed claims under the *Rooker-Feldman* doctrine, because the claims were a *de facto* appeal of a prior state court case
- Contributing brief author in *Hart v. TICOR Title Insurance Co.*, 126 Hawai'i 448, 272 P.3d 1215 (2012). The Hawai'i Supreme Court held that the insurer had improperly refused to defend the insured in litigation
- Contributing brief author in *Amina v. WMC Mortgage Corp.*, 554 F. App'x 555 (9th Cir. 2014). The Ninth Circuit upheld the district court's dismissal of the mortgagor's claims for failure to prosecute
- Contributing brief author in *Burlington Insurance Co. v. Panacorp, Inc.*, 758 F, Supp. 2d 1121 (D. Haw. 2011). The district court stayed insurance litigation pending outcome of related case filed in state court pursuant to abstention doctrine
